A position paper should be a maximum of 4 pages in which the authors present their research, preliminary results, challenges, describe their approach and how it embeds theories, methods and techniques from various approaches of research. REVIEW PROCESS: Submissions will be reviewed and selected by the conference committee led by the conference convener. Based on accepted submissions, the convener will form an expert panel by including fellow acknowledged international researchers.
